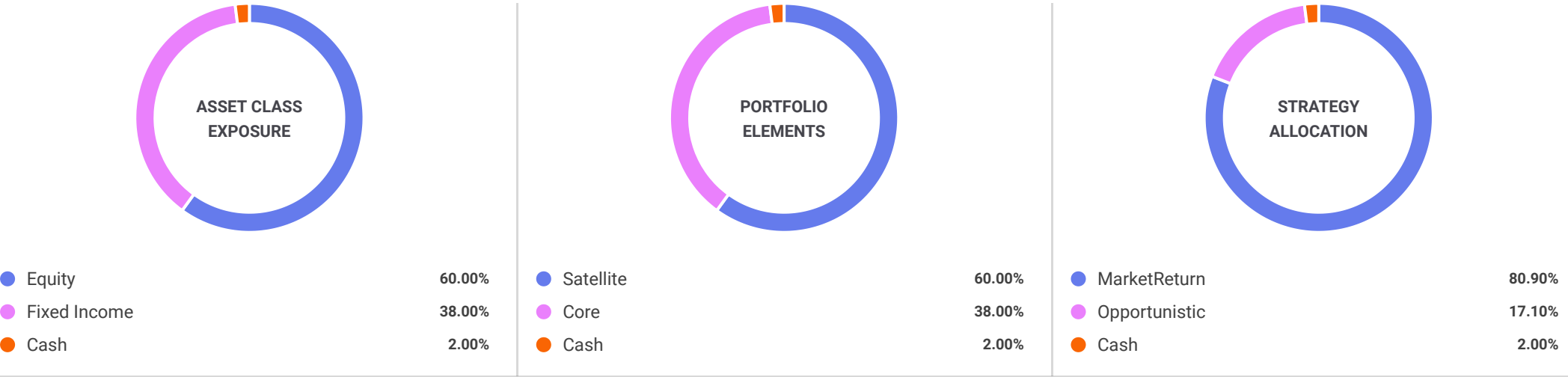
1. Description

NONE EXPOSURE RANGE



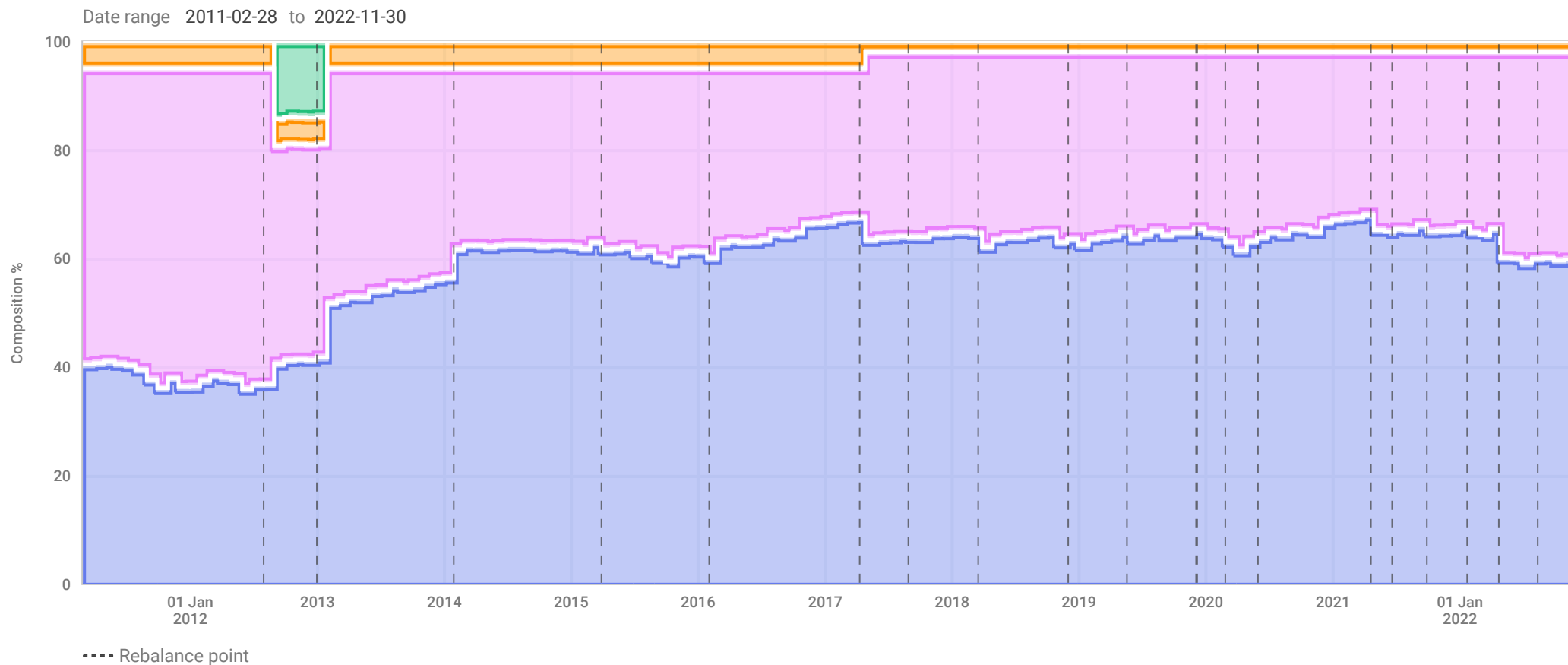
ACTIVE EXPOSURE RANGE

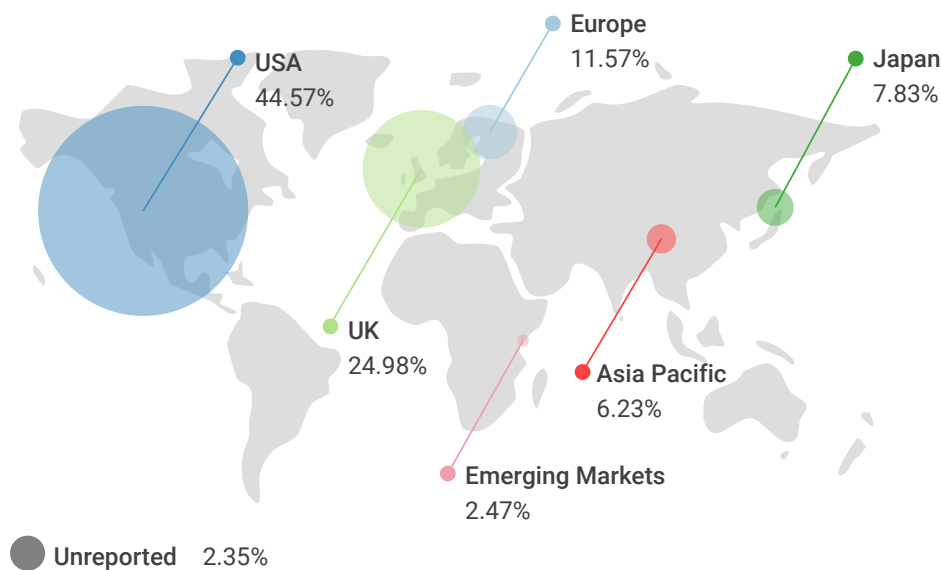

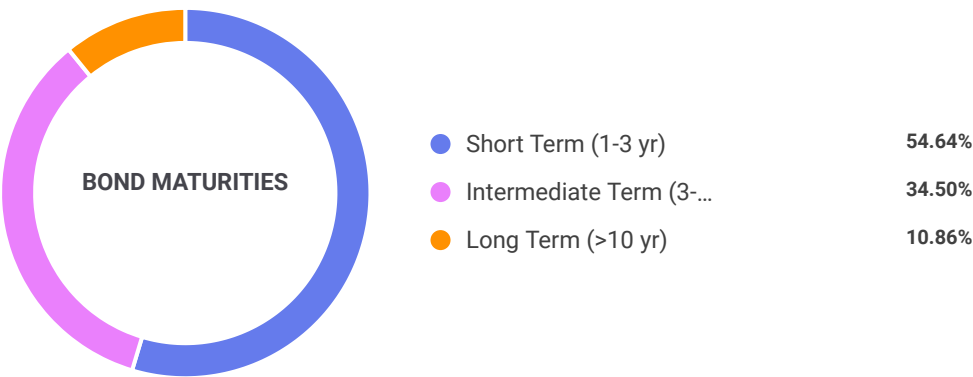

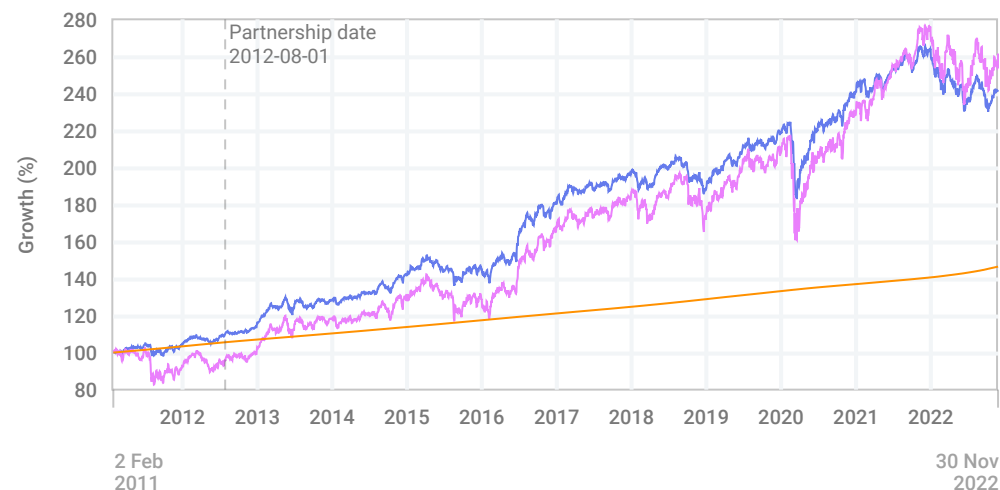
GROWTH (%) - OVER 1 YEAR

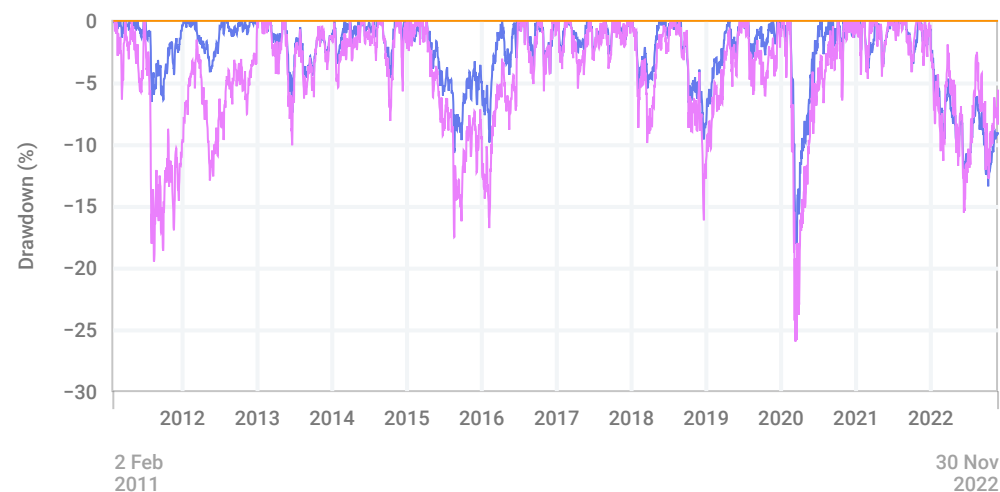
DRAWDOWN (%) - OVER 1 YEAR

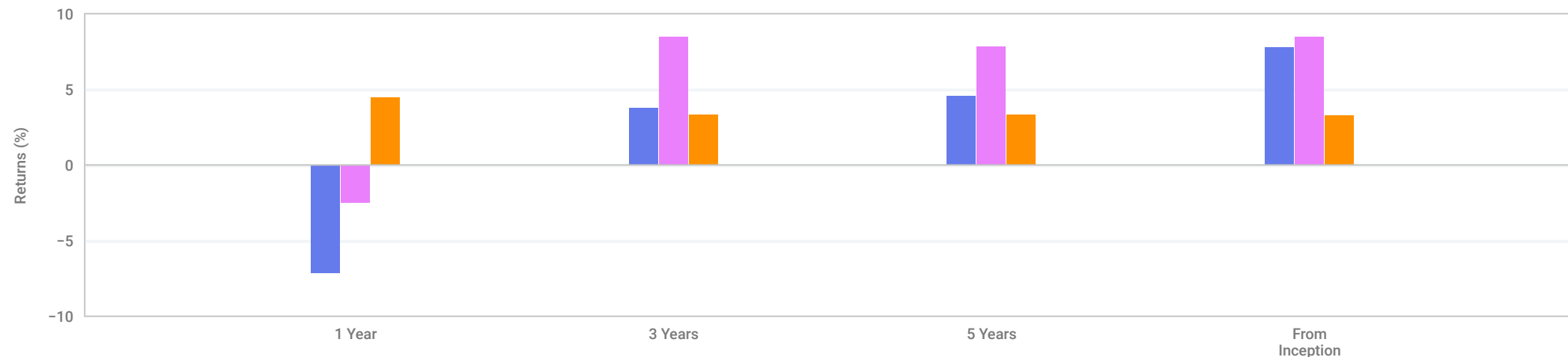

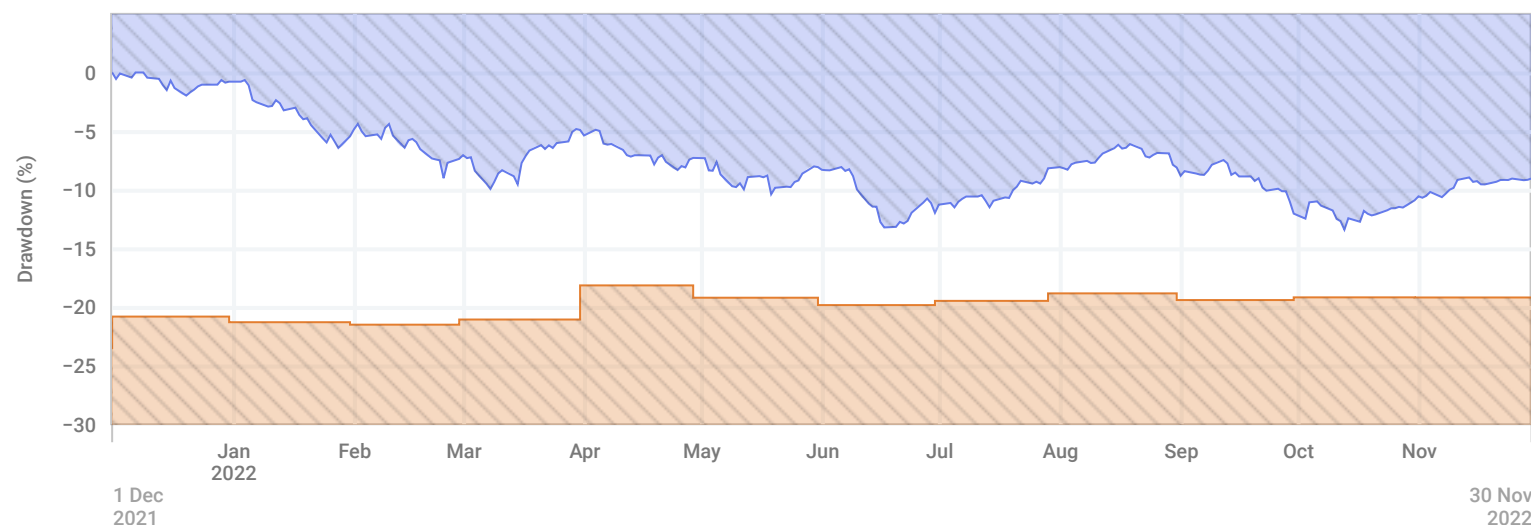
